**FELONY COMPLAINT  
FOR ARREST WARRANT**

The undersigned is informed and believes that:

COUNT 1

On or about April 7, 2018, in the County of Los Angeles, the crime of ASSAULT BY A PUBLIC OFFICER, in violation of PENAL CODE SECTION 149, a Felony, was committed by MARLENE ROCHELLE WILSON, who assaulted and beat M. C. under color of authority, the defendant being then and there a public officer, to wit, Los Angeles County Probation Officer.

COUNT 2

On or about April 7, 2018, in the County of Los Angeles, the crime of ASSAULT BY A PUBLIC OFFICER, in violation of PENAL CODE SECTION 149, a Felony, was committed by MARLENE ROCHELLE WILSON, who assaulted and beat M. C. under color of authority, the defendant being then and there a public officer, to wit, Los Angeles County Probation Officer.

COUNT 3

On or about April 7, 2018, in the County of Los Angeles, the crime of CHILD ABUSE UNDER CIRCUMSTANCE OR CONDITIONS OTHER THAN GBI OR DEATH, in violation of PENAL CODE SECTION 273a(b), a Misdemeanor, was committed by MARLENE ROCHELLE WILSON, who did willfully and unlawfully, under circumstances and conditions other than those likely to produce great bodily harm and death, injure, cause, and permit a child, M. C., to suffer and to be inflicted with unjustifiable physical pain and mental suffering, and, having the care and custody of said child, injure, cause, and permit the person and health of said child to be injured and did willfully cause and permit said child to be placed in such situation that his/her person and health was/were endangered.

COUNT 4

On or about June 3, 2018, in the County of Los Angeles, the crime of ASSAULT BY A PUBLIC OFFICER, in violation of PENAL CODE SECTION 149, a Felony, was committed by MARLENE ROCHELLE WILSON and JANETH VILCHEZ, who assaulted and beat H. S. under color of authority, the defendant being then and there a public officer, to wit, Los Angeles County Probation Officer.

COUNT 5

On or about June 3, 2018, in the County of Los Angeles, the crime of CHILD ABUSE UNDER CIRCUMSTANCE OR CONDITIONS OTHER THAN GBI OR DEATH, in violation of PENAL CODE SECTION 273a(b), a Misdemeanor, was committed by MARLENE ROCHELLE WILSON and JANETH VILCHEZ, who did willfully and unlawfully, under circumstances and conditions other than those likely to produce great bodily harm and death, injure, cause, and permit a child, H. S., to suffer and to be inflicted with unjustifiable physical pain and mental suffering, and, having the care and custody of said child, injure, cause, and permit the person and health of said child to be injured and did willfully cause and permit said child to be placed in such situation that his/her person and health was/were endangered.

COUNT 6

On or about June 14, 2018, in the County of Los Angeles, the crime of ASSAULT BY A PUBLIC OFFICER, in violation of PENAL CODE SECTION 149, a Felony, was committed by MARLENE ROCHELLE WILSON, who assaulted and beat H. B. under color of authority, the defendant being then and there a public officer, to wit, Los Angeles County Probation Officer.

COUNT 7

On or about June 14, 2018, in the County of Los Angeles, the crime of CHILD ABUSE UNDER CIRCUMSTANCE OR CONDITIONS OTHER THAN GBI OR DEATH, in violation of PENAL CODE SECTION 273a(b), a Misdemeanor, was committed by MARLENE ROCHELLE WILSON, who did willfully and unlawfully, under circumstances and conditions other than those likely to produce great bodily harm and death, injure, cause, and permit a child, H. B., to suffer and to be inflicted with unjustifiable physical pain and mental suffering, and, having the care and custody of said child, injure, cause, and permit the person and health of said child to be injured and did willfully cause and permit said child to be placed in such situation that his/her person and health was/were endangered.

COUNT 8

On or about July 21, 2018, in the County of Los Angeles, the crime of ASSAULT BY A PUBLIC OFFICER, in violation of PENAL CODE SECTION 149, a Felony, was committed by MARLENE ROCHELLE WILSON, who assaulted and beat K. M. under color of authority, the defendant being then and there a public officer, to wit, Los Angeles County Probation Officer.

**NOTICE: Conviction of this offense will require the defendant to provide DNA samples and print impressions pursuant to Penal Code sections 296 and 296.1. Willful refusal to provide the samples and impressions is a crime.**

**NOTICE: The People of the State of California intend to present evidence and seek jury findings regarding all applicable circumstances in aggravation, pursuant to Penal Code section 1170(b) and *Cunningham v. California* (2007) 549 U.S. 270.**

**NOTICE: A Suspected Child Abuse Report (SCAR) may have been generated within the meaning of Penal Code §§ 11166 and 11168 involving the charges alleged in this complaint. Dissemination of a SCAR is limited by Penal Code §§ 11167 and 11167.5 and a court order is required for full disclosure of the contents of a SCAR.**

**NOTICE: Any allegation making a defendant ineligible to serve a state prison sentence in the county jail shall not be subject to dismissal pursuant to Penal Code § 1385.**

**NOTICE: Conviction of this offense prohibits you from owning, purchasing, receiving, possessing, or having under your custody and control any firearms, and effective January 1, 2018, will require you to complete a Prohibited Persons Relinquishment Form (“PPR”) pursuant to Penal Code § 29810.**

Further, attached hereto and incorporated herein are official reports and documents of a law enforcement agency which the undersigned believes establish probable cause for the arrest of defendant(s) MARLENE ROCHELLE WILSON and JANETH VILCHEZ for the above-listed crimes. Wherefore, a warrant of arrest is requested for MARLENE ROCHELLE WILSON and JANETH VILCHEZ.
