B., to suffer and to be inflicted with unjustifiable physical pain and mental suffering, and, having the care and custody of said child, injure, cause, and permit the person and health of said child to be injured and did willfully cause and permit said child to be placed in such situation that his/her person and health was/were endangered.

COUNT 8

On or about July 21, 2018, in the County of Los Angeles, the crime of ASSAULT BY A PUBLIC OFFICER, in violation of PENAL CODE SECTION 149, a Felony, was committed by MARLENE ROCHELLE WILSON, who assaulted and beat K. M. under color of authority, the defendant being then and there a public officer, to wit, Los Angeles County Probation Officer.

NOTICE: Conviction of this offense prohibits you from owning, purchasing, receiving, possessing, or having under your custody and control any firearms, and effective January 1, 2018, will require you to complete a Prohibited Persons Relinquishment Form ("PPR") pursuant to Penal Code § 29810.
